General Conditions:

1. The bid form should be with original hand-signature.
2. The bid should identify the name, mobile, email (if any) and price offered. The vehicle will go to the highest bidder. All late bids will be rejected.

Vehicle Inspection & Questions:

The vehicles will be available for physical inspection at the IOM Mission in Kosovo at the address above during working days from 14:00 to 15:00 hrs. Please contact IOM reception or email to iomprnprocurement@iom.int to arrange your visit time or to answer your queries on this sale.

Warranty:

All vehicles are offered for sale on an "AS IS WHERE IS" basis, with no conditions of warranty.

Terms of Sale:

Bidders can offer for purchasing for one vehicle or more. The evaluation will be on the basis of the highest offered price per vehicle. IOM Kosovo reserves the right to choose the overall most favorable solution in cases when one bidder offers for all the vehicles.

Upon notification, the successful bidder must pay within three (3) working days the purchase price in cash, certified check payable to the IOM Mission in Kosovo, or by bank transfer. Should the successful bidder fail to arrange payment within three (3) working days, the vehicle will be offered to the second highest bidder.

Payment is required to be made in full before delivery or transfer of title is released.

The vehicle purchased shall be removed from the IOM Mission in Kosovo parking within three (3) working days. Payment of Customs, Registration Fees, Sales Tax and insurance or any other such cost shall be at the expense of the purchaser.

Bid security will not be refunded if the bidder failed to comply with clauses 1 and 3 of terms of sale above.

Transfer of title process is taking between 15 – 30 days after IOM Mission in Kosovo receiving of full sale amount.

The highest or any bid may not necessarily be accepted. IOM Kosovo reserves the right to reject any or all offers to purchase received.
