# What is EU-Return and Reintegration IV?

### **Objectives**

The overall objective of the EU-RRK IV is contribute to the creation of an enduring, tolerant, multiethnic environment in Kosovo which ensures the basic human rights of displaced non-majority community members to a safe, secure, and sustainable return and reintegration in dignity.

EU-RRK IV assists the returning non-majority men, women and children in their return and reintegration process and supports central and local level authorities to address the needs of these communities.

The programme works with Kosovo Ministry for Community and Return, municipal officers and minority returnees.



## **Beneficiaries:**

#### Displaced Persons in the region (DPR's):

Minority ethnic groups or persons displaced by the conflict residing in Serbia, Montenegro and FYROM (Macedonia)

#### Internally Displaced Persons (IDP's):

Minority ethnic groups or persons displaced within Kosovo

#### **Refugees:**

Minority ethnic groups or persons recognized as refugees by UNHCR or hosting government in Serbia, Montenegro and FYROM (Macedonia)

#### Criteria:

- Minority returnee who fled Kosovo as a result of the 1998-1999 or March 2004 conflict (between Jan. 1st, 1998 and March 2004);
- A member of a household do not own second inhabitable property
- The household has not previously received significant housing assistance
- Vulnerable families who are not in a position to repair/reconstruct by their own means

- Housing assistance and house reconstruction
- Harmonized assistance packages
- Trainings and Income Generation Grants
- Small scale infrastructure projects
